Environmental Policy

Grupo Jorge is active in all stages of the pork production chain, from livestock care to marketing. The products and services provided include: genetics, breeding, fattening, slaughter and cutting of pigs, curing of hams, treatment of pork byproducts (offal and viscera, feed production, protein, flour and fats), packaging, refrigeration and freezing of the product, transportation and management of wastewater from meat complexes. Grupo Jorge also has other branches of activity in renewable energies, rural farms and agricultural plantations.

Together with its team of workers, Grupo Jorge is committed to the upholding of regulations and continuous improvement with regard to transparency, while respecting its stakeholders, all of its clients and nearby local communities and authorities, always with the guarantee of fair competition and business stability.

Our Environmental Policy defines our commitment to carrying out our activity within the parameters of sustainable development and retaining control and management of environmental issues in order to ensure a good business image with respect to environmental protection.

To fulfill these commitments and achieve the established objectives, the Management has established the following fundamental principles:

- Work in a respectful manner with the environment and ensure its protection by adopting the necessary
 measures to avoid the risk of environmental contamination and minimize the environmental effects
 produced as a consequence of our activity, through continuous improvement of processes, products
 and services.
- Ensure compliance with applicable environmental legal requirements and other requirements subscribed to by the organization regarding the environment.
- Bring the Environmental Management System closer to the entire organization to encourage the active participation of all employees in order to promote continuous improvement.
- Make a clear and unavoidable commitment on the part of Management to implement and maintain the Environmental Management System and disseminate these at all levels of the organization.
- Give priority to prevention criteria over correction criteria in our principles of action.
- Maintain the sensitization and awareness of all our employees, promoting their environmental training.
- Carry out a periodic annual evaluation of the environmental aspects derived from our activity, for the purposes of maintenance and continuous improvement of the Environmental Management System.













- Minimize the use of natural resources and raw materials, prioritizing reuse and recycling, with the aim of implementing circular economy in all our processes.
- Ensure the protection of the environment that surrounds us; water, biodiversity, soil, atmosphere and society.
- Define concrete and measurable objectives and goals within an environmental program, these being subject to a review of their achievements at least once a year.
- Guarantee the necessary resources to be able to adequately carry out all the tasks that include environmental management.

All staff are responsible for achieving environmental requirements, so environmental management is the result of everyone's efforts.

All the people who make up Grupo Jorge accept these principles, and it is their responsibility to put them into practice.

Grupo Jorge is committed to achieving specific objectives to improve its impact on the environment in alignment with the 2030 agenda. These objectives are certified annually by an external entity.

• Reduction of water consumption in the Industry through improvements in processes and equipment up to 5.08 m³/Tn produced in 2026. This represents a reduction in water consumption compared to production of 6.6% since 2019.

Additionally, Grupo Jorge has joined the Science Based Target (SBTi) initiative, taking on the following reduction commitments:

- Reduction of 30.3% by 2030 of ${\rm CO_2}$ emissions (scope 1) of the FLAG category (Agriculture and livestock).
- Reduction of 42% by 2030 of CO₂ emissions (scopes 1 and 2) of the NON -FLAG category (industry).
- Reduction of 100% by 2030 of scope 2.
- Reduction of 25% by 2030 of CO₂ emissions of scope 3 of the NON-FLAG category (industry).

Management will promote environmental improvement and will allocate the necessary resources to ensure the successful implementation of the company's environmental policy.

Grupo Jorge's Management, through the Environment Department, will disseminate this Environmental Policy so that it is understood and applied by all the organization's staff.

Grupo Jorge's environmental policy will be reviewed annually and will be made public through the corporate website.
